MEMORANDUM OF UNDERSTANDING

This MoU may be extended for a further period as may be agreed in writing by the Parties.

2. FINANCIAL ARRANGEMENTS

For purposes of this MoU, "confidential information" means any information whether prior to or hereinafter disclosed by a Party (the Disclosing Party) to the other Party (the Receiving Party) of this MoU involving technical, business, marketing, policy, know-how, planning, project management and other information, data and/or solutions in any form, including but not limited to any information which is designated in writing to be confidential or by its nature intended to be for the knowledge of the Receiving Party or if orally given, is given in the circumstances of confidence.

Both Parties agree that the provisions of this clause shall continue to be binding between the Parties notwithstanding the termination of this MoU.

4. SETTLEMENT OF DISPUTES

Any difference or dispute between the Parties concerning the interpretation and/or implementation and/or application of any of the provisions of this MoU shall first be settled amicably through mutual consultation and/or negotiations between the Parties.

5. NON CONTRACTUAL NATURE OF RELATIONSHIP

Parties agree that this MoU represents the mutual understanding of the Parties and is not intended nor shall be deemed to be a contract and shall not give rise to any rights and liabilities under a contract.

MEMORANDUM OF UNDERSTANDING

Nothing contained herein shall be construed so as to constitute a joint venture partnership or formal business organization of any kind between the Parties or so to constitute either Party as the agent of the other.

The Parties acknowledge that this MoU does not in any way give rise to any right or permission to use or to be associated with each Party's intellectual property.

6. REVISION, VARIATION AND AMENDMENT

Either Party may request in writing a revision, variation or amendment of this MoU. Any such revision, variation or amendment agreed to by the Parties shall be in writing and shall form part of this MoU. Such revision, variation or amendment shall come into force on such date as may be determined by the Parties.

Any revision, variation or amendment shall not prejudice the implementation of any project, activity or co-operation arising from or based on this MoU before or up to the date of such revision, variation or amendment.

8. SUPERVENING EVENTS

- 8.1. Each Party reserves the right for reasons of national security, national interests, public order or public health to suspend temporarily, either in whole in part, the implementation of this MoU which suspension shall take effect immediately after notification has been given to the other Party.
- 8.2. Notwithstanding sub-clause 8.1, should any other event occur which hinders or restricts the implementation of this MoU, the Parties shall use their best endeavour to agree upon such action, as may be necessary and equitable, to remove the cause of such event.

9. NOTICES

Every notice, request or any other communication required or permitted to be given pursuant to this MoU shall be in writing and delivered personally or sent by registered or certified post or via air mail or via courier or facsimile or by e-mail (which shall be acknowledged by the other Party) to the Parties at their address and facsimile number as stated below:

मुगुटराव साहेबराव काकडे महाविद्यालय सोमेश्वरनगर, बारामती व महाराष्ट्र साहित्य परिषद यांच्या संयुक्त विद्यमाने मराठी विभाग आयोजित 'मराठी भाषा संवर्धन पंधरवडा' दूरदृश्यप्रणाली पद्धतीने साजरा करण्यात आला. यानिमित्ताने मा.सुनिताराजे पवार, कोषाध्यक्ष महाराष्ट्र साहित्य परिषद पुणे येथील मार्गदर्शक वक्ते म्हणून उपस्थित होत्या. 'भाषा, साहित्य आणि समाज' या विषयावर त्यांनी सविस्तर मांडणी केली. या विषयावर अतिशय अभ्यासपूर्ण, वैचारिक उंची गाठणारे आणि सहज-सुंदर, सोप्या शैलीत आणि सर्वसामान्यांच्या बोलीत मराठीच्या अस्तित्वाचा आणि भवितव्याचा त्यांनी वेध घेतला. मराठी भाषा आणि मराठी साहित्य यांचा पूर्व इतिहास सांगत मराठी भाषा आणि साहित्याच्या समृद्ध अशा गौरवशाली परंपरेवर त्यांनी प्रकाश टाकला. समृद्ध जीवनानुभव असणारा साहित्यिक, साहित्यिकाने निर्माण केलेली साहित्यकृती आणि त्या साहित्यकृतीचा समाज जीवनावर होणारा परिणाम यांचा काय अनुबंध आहे हे त्यांनी अनेक उदाहरणांच्या आधारे समजावून सांगितले. माणसाच्या आयुष्यामध्ये मातृभाषेचे व साहित्याचे काय महत्त्व आहे? हे त्यांनी नेमकेपणाने उलगडून दाखवले. वाचन संस्कृतीचा विकास ही काळाची गरज असून वाचनानेच माणूस समृद्ध व प्रगल्भ होऊ शकतो. वाचनच माणसाला दिशा देतात तेव्हा विद्यार्थ्यांनी अधिकाधिक वेळ ग्रंथालयात व्यतीत करावा असेही त्यांनी सुचविले. आपली मराठी भाषा अतिशय सुंदर आहे, ती कधीही नष्ट होणार नाही. तिला हजारो वर्षांची परंपरा आहे. तिचा आपण आवर्जून वापर करू व तिला सर्वश्रेष्ठ ठरवू! असा आशावाद व्यक्त केला. महाविद्यालय व्यवस्थापन समितीचे सचिव मा. जयवंतराव घोरपडे यांनी कार्यक्रमाला मनःपूर्वक शुभेच्छा दिल्या आणि मराठी विभागाच्या या उपक्रमाचे कौतुक केले. अध्यक्षस्थानी महाविद्यालयाचे प्राचार्य मा. डॉ. देविदास वायदंडे होते.
